What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Fund may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

The Sub-Fund has for objective to provide its investors with a medium-long term capital growth, by a diversified portfolio of equity securities issued by international companies listed on official stock markets and debt securities issued by international issuers, qualifying as transferable securities. The investment approach follows an active management strategy without regard to geographical or sector allocation, security type or size.

The Sub-Fund mainly invests in equity and equity related securities (including but not limited to ADR/GDR), any kind of debt instruments (including but not limited to bonds and convertible bonds), money market instruments or assimilated products (such as commercial papers, and in general instruments with a maturity lower than twelve months) and derivatives.

The Sub-Fund may allocate up to 90% to equity and equity related securities (including ADR/GDR); up to 100% in short term (max 12 months) government bonds issued by G20 Countries. The Sub-Fund will not invest more than 50% in equities quoted on Emerging Market's stock exchanges; will not invest more than 50% in Non-Investment Grade bonds, including bonds issued in Emerging Markets; will not invest more than 20% in contingent convertible bonds; and will not invest more than 15% in non-rated bonds. These limits only apply to direct equities, bonds and related securities and UCITS and/or UCIs investing principally in equities and bonds; i.e. financial derivative instruments on equities or on bonds are not taken into account for the calculation of these restrictions.

If a debt securities has not been given a credit rating by a recognized agency, the Board of Directors may, appreciate whether one instrument possesses the equivalent of at least High Yield rating criteria (at the issuer or at the issue level). The Sub-Fund will not invest in Distressed Securities or Defaulted Securities. However, in the event of downgrading in the credit ratings of a security or an issuer to distressed or defaulted, the Sub-Fund may continue to hold those debt securities which have been downgraded, provided that in any case the Sub-Fund's maximum exposure to Distressed Securities or Defaulted Securities will be limited to a maximum of 10%.

The allocation will be done either directly or indirectly through other UCITS and/or UCIs (limited to 10%). The Sub-Fund may invest up to 20% in structured products. The Sub-Fund can be exposed for a maximum of 50% in Emerging Markets. The Sub-Fund will not invest directly in ABS/MBS or in TRS.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments. Nevertheless, in normal market conditions, the Investment Manager will (largely) favour financial indices, interest rates, foreign exchange rates or currencies.

Benchmark The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 year.

The minimum subscription amount for the Class is 5,000 EUR.

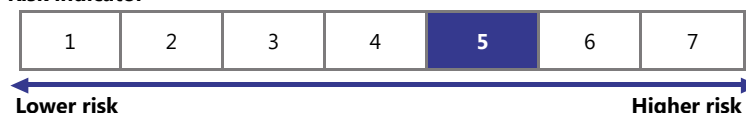
Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
