What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Fund may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

The Sub-Fund invests in equity and equity related securities (including, but not limited to, ADR, convertible bonds, equity linked notes, low exercise price warrants and warrants on equities); these investments shall be represented by direct or indirect investments (including but not limited to CFDs) in securities listed in eligible stock exchanges or traded on Regulated Markets of North America and Europe. The Sub-Fund will adopt a long/short strategy according to which long positions will be represented, directly or indirectly by use of derivatives such as CFDs futures and options, by investments in equity securities, and the short positions will be represented exclusively by derivative instruments (through the use of CFDs, futures or options) to obtain synthetic purchase or short sale positions. In particular, the use of options on indices will notably have the aim to reduce the correlation to the market and the volatility of the portfolio. Investment decisions for the selection of long and short positions are based on screening models and fundamental research. The performed fundamental analysis defines the companies that could be invested both long and short. The companies, both long and short, weight in the portfolio on the basis of the realized historical volatility and the investment are constantly monitored and adjusted on the basis of the suggestions of the proprietary trading models.

The Sub-Fund may also invest in debt instruments (corporate or sovereign), money market instruments or assimilated instruments, rated at least B-/B3. In case of any debt instrument's rating being downgraded by one or more of the main rating agencies to Non-Investment Grade, the Investment Manager shall be authorized to keep the investment as long as this is not detrimental to the best interest of shareholders and upon proper analysis.

The Sub-Fund will not invest in Distressed Securities or Defaulted Securities. However, in the event of downgrading in the credit ratings of a security or an issuer to distressed or defaulted, the Sub-Fund may continue to hold those debt securities which have been downgraded, provided that in any case the Sub-Fund's maximum exposure to Distressed Securities or Defaulted Securities will be limited to a maximum of 10% of its net assets.

It is understood that the Sub-Fund will not invest more than 10% of its net assets in ADR directly; 10% of its net assets in convertible bonds; 10% in contingent convertible bonds, (the contingent convertible bonds will be rated at least B-/B3 (as rated by any of the main agencies) and will be issued by banking/insurance institutions located in OECD countries rated at least Investment Grade.

The allocation will be done either directly or indirectly through other UCITS and/or UCIs (limited to 10% of the Sub-Fund's net assets). The Sub-Fund may invest up to 20% of its net assets in structured products. The Sub-Fund may be exposed, directly or indirectly, for up to 10% of its net asset to Emerging Markets. Nevertheless, the Sub-Fund will neither invest directly in the Chinese market of A-Shares, the Indian market of P-Notes nor will invest directly in Russia, but may be exposed to these countries/ specific assets via eligible target funds.

The Sub-Fund will not invest directly in ABS/MBS. This ABS/MBS restriction (this waived for indirect investments such as target funds, i.e. no look-through). The Sub-Fund will not enter in TRS.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments. Nevertheless, in normal market conditions, the Investment Manager will largely favour futures and options.

Benchmark The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is reserved for institutional investors. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years.

The minimum subscription amount for the Class is 250,000 EUR.

Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
