What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TFRM

The Sub-Fund is established for an unlimited duration. However, the Fund may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

The Sub-Fund mainly invests in any kind of debt instruments (including bonds, convertible bonds) and Money Market Instruments or assimilated products (such as commercial papers, and in general instruments with a maturity lower than twelve months) denominated in any currencies. Without being a constraint, investments in debt instruments, convertible and contingent convertible bonds will be focused on securities issued by European and North American issuers.

The Sub-Fund shall invest in debt instruments issued by issuers with a credit rating of at least Ba2/BB. Nevertheless, the Sub-Fund can be exposed for a maximum of 10% to investments issued by rated issuers with a credit rating below Ba2/BB.

Among the convertible bonds, the Sub-Fund may invest maximum 40% in contingent convertible bonds (which must have a mechanical trigger). The contingent convertible bonds will be rated at least B-/B3 and will be issued by banking/insurance institutions located in OECD countries rated at least Investment Grade. The mechanical trigger of the contingent convertible bonds would result in a mix of reduction in value of the instrument or suspension of the coupon payment.

The Sub-Fund may also invest in non-rated bonds up to a maximum 10%. If the fixed income instruments issuer/the issue has not been given a credit rating by a recognized agency, the Board of Directors may, appreciate whether one instrument possesses the equivalent of at least High Yield rating criteria (at the issuer or at the issue level). Without being a constraint, the expected average rating will be BBB / B.

For money market instruments, the short-term rating (which may be esteemed at the issue or at the issuer level) shall be at least P3/A3.

The Sub-Fund will not invest in Distressed Securities or Defaulted Securities. It is understood that, in the event of downgrading in the credit ratings of a security or an issuer to distressed or defaulted, the Sub-Fund may continue to hold those debt securities, provided that in any case the Sub-Fund's maximum exposure to Distressed Securities or Defaulted Securities will be limited to a maximum of 10%.

Total investments in equity and equity related securities will be limited to 20%, while investments resulting of conversion of a contingent convertible bonds shall be limited to 10%. The allocation will be done either directly or indirectly through other UCITS and/or UCIS (limited to 10%). The Sub-Fund may invest up to 20% in structured products. The Sub-Fund can be exposed, directly or indirectly, for a maximum of 15% to Emerging Markets. The Sub-Fund will neither invest directly in the Chinese market of A-Shares, the Indian market of P-Notes nor will invest directly in Russia, but may indirectly be exposed to these countries / specific assets via eligible target funds. The Sub-Fund will not invest directly in ABS/MBS. It shall however be mentioned that this ABS/MBS restriction that apply to direct investment in this asset class is waived for indirect investments such as target funds (i.e. no look-through); and in TRS.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments. Nevertheless, in normal market conditions, the Investment Manager will largely favour futures, options, CFD and CDS.

Benchmark The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years.

There is no minimum subscription amount for the Class.


Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator



Higher risk

The risk indicator assumes you keep the product for 3 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. The essential risks of the investment fund lie in the possibility of depreciation of the securities in which the fund is invested.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance, so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Performance scenarios

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
