What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TFRM

The Sub-Fund is established for an unlimited duration. However, the Fund may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

The Sub-Fund aims to seek a consistent, absolute return while placing emphasis on the preservation of capital in the medium term. The Sub-Fund's long term objective is capital growth. The investment strategy is based on the identification of equity stocks, which show the best investment opportunities.

The Sub-Fund may allocate up to:

- 100% with a minimum of 51% of its net assets to listed equities and equity related securities (including ADR/GDR) it is understood that these limits apply to direct investments and to UCITS and/or other UCI established as Exchange Traded Funds and investing principally in equities; and
- 30% of its net assets to bonds, convertible bonds and other fixed income securities it is understood that this limit applies to direct investments and to UCITS and/or other UCI established as Exchange Traded Funds and investing principally in bonds and other fixed income securities.

With respect to the above restrictions, it is emphasized that financial derivative instruments on equities or bonds are not taken into account for the calculation of these restrictions. The allocation of the portfolio between the different various assets classes, sectors and/or geographical exposures may vary according to the Investment Manager's expectations. The allocation will be done either directly or indirectly through other UCITS and/or other UCI. The management fees of the target UCIs will be limited to a maximum of 0.8%.

It is understood that, in the event of downgrading in the credit ratings of a security or an issuer to distressed or defaulted, the Sub-Fund may continue to hold those debt securities which have been downgraded, provided that in any case the Sub-Fund's maximum exposure to Distressed Securities or Defaulted Securities will be limited to a maximum of 10% of its net assets.

Exposure to Emerging and Frontier Markets will be limited to 49% of the Sub-Fund's net assets. The Sub-Fund may invest up to 10% of its net assets in structured products. The Sub-Fund will not use TRS. The Sub-Fund will not invest in contingent convertible bonds, and directly and indirectly in ABS and MBS. The Sub-Fund will not invest in Distressed Securities or Defaulted Securities.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments. Nevertheless, in normal market conditions, the Investment Manager will largely favour futures.

Benchmark The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is reserved for institutional investors. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 3 years. The minimum subscription amount for the Class is 50,000 EUR.

Asset segregation The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

Dealing The NAV for the Class is calculated on each bank business day in Luxembourg. The cut-off time to submit subscriptions and/or redemptions orders is 2 p.m. Luxembourg time on the bank business day preceding the relevant calculation day.

Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
